The contract is between

By concluding this Agreement, the Breeder and the Buyer agree:

1.1. The kitten is transferred to the Buyer at the age not earlier than 12 weeks. Together with the kitten, the Buyer from the Breeder receives:

- pedigree (with the exception of the case provided for in clause 4.2, and if the Buyer refuses it);
- a veterinary book with marks of vaccination and deworming;
- nutritional and care recommendations.

1.2. **The breeder guarantees** the kitten's conformity with the quality stipulated by the Contract at the time of sale, and does not give any guarantee regarding the future animal show career and reproductive quality.

2.1. **The Buyer has the right** to examine it at the veterinary clinic within five days after receiving the kitten and, in case of detection of previously unknown diseases witnessed by the veterinarian in writing, the Breeder promises to collect the animal by returning the amount received to the Buyer in according to this Agreement. If the Buyer does not use these rights, further claims regarding to the state of health of the animal are not accepted.

2.2. If the kitten dies before the age of one year, and the cause of death is a hidden congenital defect, including genetic nature, confirmed by a veterinarian in writing, the **Breeder agrees** to provide the Purchaser with an adequate animal as soon as it appears in the nursery. **The breeder is not responsible** for the death of the animal as a result of bacterial and viral infections.

3.1. **The buyer agrees** to provide the acquired animal with a comfortable living environment, including an area of at least 5 m<sup>2</sup>, natural or artificial light during the daytime, air temperature in the room from + 10 ° to + 25 °, good ventilation, clean dishes for feeding and a special toilet with the appropriate filling, which is regularly cleaned, as well as toys and accessories for climbing and claw points.

3.2. **The buyer agrees** to provide conditions that exclude the uncontrolled location of the animal outside the premises (the cat older than six months can be freely located outside the premises, if it is sterilized).

3.3. **The buyer agrees**, if necessary, to provide the animal with timely veterinary assistance.

3.4. **Buyer** in case of disappearance or destruction of the animal must inform the Breeder.

4.1. If the kitten is sold as an animal of the show class, **the Buyer agrees** to exhibit the animal at the international cat show organized by the cat lovers club for at least one year after the conclusion of this Agreement.

4.2. If the kitten is sold as a pet of the "pet" class, **the Buyer agrees** not to use it for reproduction, as well as at the age of 7-10 months to sterilize (castrate) the animal. The buyer receives the pedigree of the animal from the Breeder upon completion of sterilization (castration), and providing the Breeder with a veterinarian's certificate of this operation.
